## Background Information

CD21, also known as complement receptor type 2 (CR2), complement C3d receptor, and Epstein-Barr virus receptor, is a transmembrane protein that contains a small cytoplasmic domain, a transmembrane region and an extracellular domain consisting of 15 tandem short consensus repeat sequences (PMID: 6230668; 2551147). It is expressed on B cells, follicular dendritic cells, thymocytes and a subset of peripheral T cells (PMID: 26119182). CD21 binds complement fragments C3d, C3dg and iC3b and acts as a receptor for the Epstein-Barr virus (PMID: 7753047). On B cells, together with CD19 and CD81, CD21 forms a complex that functions as a co-receptor to the BCR (PMID: 7542009). It is involved in B cells activation and functions.



1x10<sup>6</sup> human PBMCs were surface stained with FcZero-rAb™ CoraLite® Plus 488 Anti-Human CD19 (4G7) or FcZero-rAb™ PerCP-Cyanine5.5 Rabbit IgG Isotype Control Recombinant Antibody (CPY5-FcA98136, Clone: 240953C9), and 5  $\mu$ l PerCP-Cyanine5.5 Anti-Human CD21 (BU32) Rabbit IgG RecAb (CPY5-FcA65591, Clone:BU32). Cells were incubated with MonoZero™ Monocytes blocking Reagent (PF00020) prior to staining. Cells were not fixed.



1x10<sup>6</sup> human PBMCs were surface stained with 5  $\mu$ l PerCP-Cyanine5.5 Anti-Human CD21 (BU32) Rabbit IgG RecAb (CPY5-FcA65591, Clone:BU32) (red) or FcZero-rAb™ PerCP-Cyanine5.5 Rabbit IgG Isotype Control Recombinant Antibody (CPY5-FcA98136, Clone: 240953C9) (blue). Cells were incubated with MonoZero™ Monocytes blocking Reagent (PF00020) prior to staining. Cells were not fixed. Lymphocytes were gated.
